

NOW, THEREFORE, THIS MEMORANDUM OF UNDERSTANDING
WITNESSES AS UNDER:

1. The party of the second part shall impart knowledge and provide mentor-ship training to the individual in accordance with the courses and syllabus designed by academic regulatory authority. The party of the second part shall from time to time update the party of the first part with the approximate number of individual interested and eligible for engagement for on the job practical training.

2. The party of the first part shall from time to time facilitate selection of individual from institute for on the job practical training as well as other modes of corporate-institute dialogue. The party of the first part shall also communicate the individual selection procedure such as eligibility criteria, selection procedure, campus interview, etc. or any other method that it may deem fit in discussion with relevant company or organization. The party of the second part shall provide necessary assistance in arrangement of campus interview, communication with interested candidates, pre-selection or institutional training if required etc.

3. The training period, depends of the individual under the party of the first part shall be in accordance with the Govt. guidelines as well as company or organization requirements. The party of the first part shall strive to provide on the job practical training in accordance with the Govt. or Company Standards and for that purpose the party of the second part shall provide the relevant training in multi-modal formats and develop required course material for delivery to the party of the first part or directly to the student. The party of the first part shall also strive, as far as possible, to provide the training in first or general shift i.e. between 7 am till 7 pm. The party of the first part shall intimate the party of the second part from time to time about change of timings/shifts of the individual.

4. The party of the first part shall follow Company or organization rules, regulations, and code of conduct & same will be followed by every individual during the training period.
